# Participant Liability Waiver

## Streets of Lancaster Grand Prix

Thank you for participating in this exciting and fun recreational opportunity in Lancaster. By completing this form you agree to release the City of Lancaster and organizations participating in the **Streets of Lancaster Grand Prix** (the “Activities”) of all liability while serving as a participant. This Release and Waiver of Liability (the “Release”) is executed on this **12<sup>th</sup>-13<sup>th</sup> day of September, 2017** by \_\_\_\_\_ (the “Participant”) in favor of the City of Lancaster, as well as its officers, agents, servants and employees and organizations sponsoring or hosting the Activities (collectively, “City of Lancaster”).

The Participant desires to participate in the Activities. The Participant understands that the Activities will include driving a go-kart on a closed track at the **Antelope Valley Fairgrounds (September 12-13, 2017) and through the streets of downtown Lancaster (September 29-30, 2017)**. The Participant agrees to follow safety procedures and abide by all instructions while participating in the Activities.

The Participant hereby freely, voluntarily, and without duress executes this Release under the following terms:

**Release and Waiver:** Participant does hereby release and forever discharge and hold harmless the City of Lancaster and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Participant’s participation in the Activities.

Participant understands that this Release discharges the City of Lancaster from any liability or claim that the Participant may have against the City of Lancaster with respect to any bodily injury, personal injury, illness, death, or property damage that may result from the Participant’s participation in the Activities, whether or not caused by the negligence of the City of Lancaster or its officers, or assigns.

Participant also understands that the City of Lancaster does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

**Medical Treatment:** Without limiting the generality of the foregoing, Participant does hereby release and forever discharge the City of Lancaster from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Participant’s participation in the Activities.

**Assumption of the Risk:** The Participant hereby expressly and specifically assumes the risk of any and all injury or harm that may result from the Participant’s participation in the Activities and releases the City of Lancaster from all liability for injury, illness, death, or property damage resulting from the Participant’s participation in the Activities.

**Insurance:** The Participant understands that the City of Lancaster does not carry or maintain health, medical, or disability insurance for or on behalf of the Participant.

**Photographic Release:** Participant does hereby grant and convey unto the City of Lancaster all rights, title, and interest in any and all photographic images and video or audio recordings made by the City of Lancaster during the Participant's participation in the Activities, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

**Other:** The Participant expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California and that this Release shall be governed by and interpreted in accordance with the laws of the State of California. Participant agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
